Private Personal Data: Data on a person's race, ethnic origin, political and philosophical opinions, religion, religious sect and other beliefs, apparel, membership information to associations, foundations or syndicates, sexual life, conviction, security measures, biometric and genetic information.

Data subjects have the following rights according to their relation with Amesia Gıda Tarım Hayvancılık Nakliye Sanayi Ve Ticaret Limited Şirketi: The right be informed on whether their personal data are processed or not; The right to obtain related information on the details of the process; The right to inquire the reason for processing their personal data and its conformity with legitimate purposes; The right to obtain information on the third persons (at home or abroad) to whom their data are transferred; The right to have inaccurate personal data rectified, or completed if it is incomplete; The right to request erasure or disposal of their personal data according to the provisions at Article 7 of the Law; The right to request notification of the operations carried out in compliance with sub-paragraphs (d) and (e) to third parties to whom his personal data has been transferred; The right to object in cases of exclusive processing of their personal data by automated systems which produce unfavorable effects to the data subject; The right to claim compensation for damages arising from the unlawful processing of his personal data;

After applying, authentication may be required.
